## ACCIDENT WAIVER & RELEASE OF LIBILTY

I acknowledge & have been informed that this program is not a licensed childcare facility. I also understand that this program is not required to be licensed by the Georgia Department of Early Child Care and Learning. This program is exempt from state licensure requirements.

In consideration of your son's participation in our program, I hereby release **The M.E.N.S Club**, and its agents, representatives, directors, officers, servants, employees, volunteers, affiliates, and assigns from any and all present and future claims, demands, expenses, causes of action, lawsuits, damages and liabilities of every kind and nature, whether known or unknown, in law or equity that I or my child ever had or may have arising from or in any way related to my son's participation in any program(s), events or activities conducted by or on any location i.e. churches, schools or off the premises of or for the benefit of **The M.E.N.S Club** whether by agreement, by operation of law or otherwise.

I hereby assume all of the risks of participating in **The M.E.N.S Club**, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them, or because of their possible liability without fault.

I further consent that my identity may be revealed therein or by description text or commentary. I waive any rights, claims or interest and I understand that there will be no financial or other remuneration. The accident waiver, release of liability and image release shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
